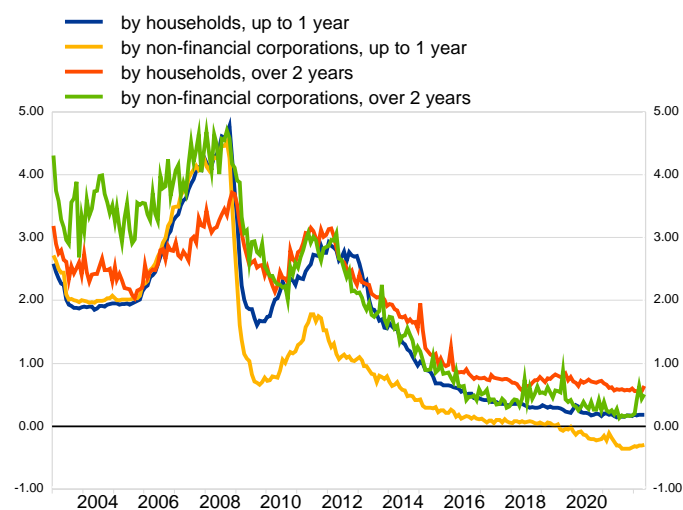

(percentages per annum excluding charges; period averages)

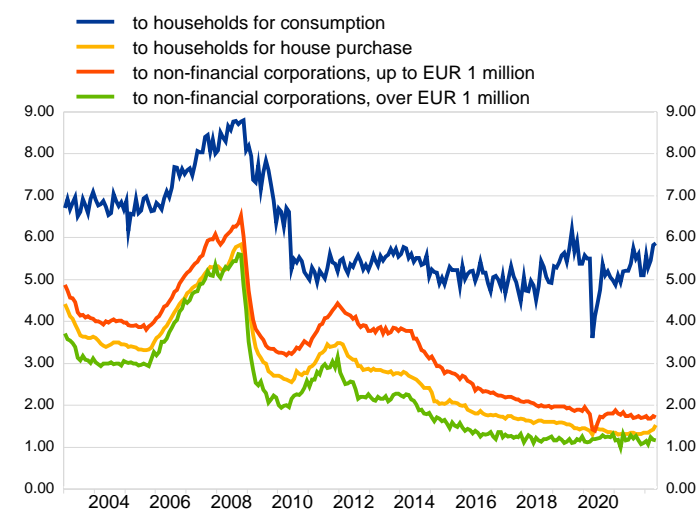
